On Friday June 10th I am working near the gate waiting on the Police, they never arrive. The anticipated Real estate agent Lori had arrived though, with Bill a process server, and a locksmith. They proceeded to explain how they had the proper documentation for eviction.

The sheriff is busy, and Paul Solla is with officer Hector heading to Hilo for verification. I return to the house and call officer Hector he is with Solla. I informed them of the situation and that I needed the Police here. Lori & Solla's crew were saying the police were busy with real problems like drugs and abuse. That this situation had no importance to the legal system. Well they spoke of cutting the lock and where's the sheriff he should be here. So when I returned to the gate I allowed them access, putting the lock in my pocket. I am told Paul was getting document in Hamakua coast and would not arrive there today.

They asked me for the keys to the house make it easier. I would not give them keys. They proceeded to change locks anyway. At one point they were told to stop and they did. But once Paul was done with the Police he called and instructed them to continue. I have been told I have 3 hrs to leave, get my stuff out. I made a few calls while they were doing their "Job"? To Sherry & Lew, to the police again! where are they? I get one last call to Hector before Lori tells me they are not going to allow me any more calls.

Then Joe Shows up and starts taking pictures of all

the Cars and Participants. Paul is here by then. They all scatter like Rats. Joe is forceful in his approach, Telling them all to get out. They had been telling me I had no authority, that they were in authority, that I really had no rights? my stuff had been locked away in Several Rooms I had no access to any longer.

Once Joe was in the house and trying to use the phone they removed it from the wall, locking the cord in their car. Now Joe and I are in the house alone, locksmith finished & wanted Lori to sign off. Joe starts removing the door locks at house access. They did not like that. We put a piano in front of the door. We wait where are the Police? Joe goes out to get in his car to call 911 again by cell. he encounters paul at the gate as they are returning with a moving van. I have not moved out yet! where are the Police ??? Sheriff ??

Oh it is a State Holiday they are short staffed & there is no Sheriff on Duty.

Joe returns to house, the whole front yard now full of Cars & People Ready to take Possession of this house & property. It is intimidating to be in house with no phone. my phone that keeps me safe & in contact. All their actions did not ~~not~~ support their truth, they were very aggressive at times, Declaring they would not leave, that we were in the wrong, we had no authority.

The Police arrive finally after one last 911 call made when Joe went to the gate again, we felt stronger together.

But this had to end.

Then the Police arrived in 2 cars! Yes!! Finally! They came right to me and asked what I wanted to happen. I am the authority here! Get them all out of here moving van & all. I want my phone cord! Lori takes it out of her trunk. She will not give me the keys to the newly leased house. We replaced them once we left it was safe to leave. Paul had told the Police at the gate it had all been worked out! I told them it had not at all. Thankful they arrived, I asked what had taken so long? As soon as they went off shift they were sent. Paul was not allowed to come near our conversation, and was asked to stay at gate.

June 14th If any of this were legal the police would not have made him leave. What a lot of lies and bullying. I felt trapped and unsafe as locks were changed and phones removed after asking them not too.

Today Paul sulla called me and threatened to sue me for \$500⁰⁰ a day for staying in this house as instructed to Leonard & Sherry. This is very stressfull, I feel at disease all the time feeling someone is or Paul is always breathing down my neck.


This is all taking place at Steam Vents Inn, at 13-3775 Pahoa Kalapana Rd, Pahoa HI 96778.


