**MOTION FOR TEMPORARY RESTRAINING ORDER  
AND PRELIMINARY AND PERMANENT INJUNCTIONS**

The Plaintiffs, Princess Carmen Ka'anā'anā, for the Hawaiian Kingdom, and its Protected Persons, and for Mauna a Wākea, respectfully submit an application for a preliminary injunction and moves this Court for:

1. an ex parte temporary restraining order for protection enjoining Defendants and any other person acting on Defendant's behalf or authority from:
  - A. Construction of the Thirty Meter Telescope International Observatory (TMT) until:

1. Defendants provide proof of title superior to Plaintiff's for their construction site at Mauna a Wākea;
2. Defendants have established their required legal relations with the *de jure* property owner, and the single *de jure* representative of the Hawaiian Kingdom, and its temporarily ousted Sovereign

B. Issuing a "TRAVEL PERMIT" denying Plaintiffs access to their Mauna a Wākea and their Constitutional rights.

2. An order of injunction enjoining Defendant, and any other person acting on Defendant's behalf or by their authority, from committing those acts set forth herein.
3. An order for Defendants to immediately establish required "legal relations" with the Plaintiffs as the *de jure* property owners, and as the single *de jure* representative of the Hawaiian Kingdom, and its *de jure* temporarily ousted returning Sovereign.
4. An order for Defendants to immediately transfer Kaho'olawe island to Plaintiffs.
5. An order for Defendants to request a neutral State or organization to undertake their functions performed under the 4th Geneva Convention.
6. An order awarding fees, costs, salary, and other relief to Plaintiffs, and such further relief as the Court deems just and appropriate.

This motion is made pursuant to Rule 65. Injunctions, of the Hawaii Rules of Civil Procedure, and is based upon the supporting affidavit and exhibits.
